Havelock Belmont Methuen Lakes Association by Rick Rye Vice President LKRA

The Havelock Belmont Methuen Lakes Association has continued to meet approximately every two months over the Fall and Winter to Develop a Charter and to continue the dialogue on prioritizing issues impacting our lakes.

A formal charter for the Association has been drafted and approved with our mandate defined as:

- To Share Lake Concerns, Issues and Expertise
- To Promote and Protect our Lakes
- To act as a liaison with the Township/FOCA and other Government agencies
- To promote and act upon issues and concerns impacting our lakes

The Association has been very active with the newly elected Township Government on issues such as upgrading the Township web site to improve communication with cottagers and as well in encouraging the Township to distribute to all current and future lake front owners a brochure on how to Protect and Restore Shorelines on our lakes. The web site has been upgraded and now is much more user friendly and informative and the Brochure is in the final stages of review and will be available this Spring for distribution.

On April 5th I along with other members of the Lakes Association attended the public budget review session and expressed our concerns about the proposed 6.6 percent planned cost increase given that inflation is running around 2 percent.

Council agreed to take a further look at the costs but I would expect minimal changes. At the conclusion of this budget meeting we as well requested that the Township Council give some thought to introducing a holding tank/septic system review process for the Township as a first major step in protection of our lakes. Council is discussing this issue at the County level and we expect to hear more in the near future.

In the upcoming year the Township Council will be working on updating the official plan and by-laws which impact our Lakes and I would strongly recommend that cottage residents get involved in the process as these decisions will not only impact you now but for years going forward.

Land Use Planning in Ontario, and in Havelock-Belmont-Methuen

Ontario's waterfront property owners are a major economic force in rural Ontario. Using appropriate planning policies, and providing the tools to deliver them, will help to ensure the long-term contribution of these areas to Ontario's prosperity and health. Ontario's waterfront property owners contribute more than \$500 million in property taxes annually, and collectively provide the financial means for a great deal of local infrastructure.

What is FOCA concerned about?

- The health and management of Ontario's 250,000 lakes and rivers and their surrounding watersheds
- The PPS (Provincial Policy Statement) which sets the overall goals and objectives for our waterfront communities in Ontario
- The sustainability of our province, our communities, and the environment
- Ensuring waterfront owners have a say in key land use decisions for their communities

What is FOCA doing:

FOCA recently recommended to the province that they put specific emphasis on waterfront recreational communities, because without the provincial emphasis there will continue to be no consistency (and may be some disregard for waterfront properties) at the municipal township level. In 2010 FOCA commented on the Provincial Policy Statement (PPS), because the PPS provides policy direction on matters of provincial interest, and is the foundation for the development and use of land.

The definitions in the current PPS overlook the lands designated as "Waterfront Area" in Official Plans. The resulting lack of clarity along with the limited perspectives of many township level governments, results in a wide divergence in the effectiveness of locally developed waterfront policies in Ontario to require adequate environmental protection policies while providing for low density residential and suitable commercial development opportunities. FOCA believes the Province must develop PPS policies that specifically apply to "Waterfront Areas" and require land use policies that result in the sustainable use of these special areas.

In keeping with the PPS intent for planning authorities to protect, improve or restore the quality and quantity of water, we note there are several means of protecting recreational lake and river integrity which are not adequately addressed in current provincial, and local planning:

- building setbacks from the waterfront
- building massing and height and appearance from the lake
- docks and other in-water construction
- the PPS and the Ontario Building Code should provide clear support and direction for the technical and funding aspects of on-site wastewater (septics) oversight
- the absence of planning oversight and/or expertise in rural Ontario, due to limited budgets, availability of technical expertise, and for monitoring and compliance
- local discretion, which can allow a long-term vision to be insidiously undermined by on-going incremental "exceptions" that, over time, go unmanaged, unmonitored and are potentially inconsistent with the principles espoused in the PPS

What's next:

The PPS review is underway through 2011 and likely into 2012. Make sure you have your say about the guiding policies coming from the Province.

What you can do:

Learn about HBM's upcoming Official Plan, which help translate the PPS into real goals for your community, through the municipal offices, or the new HBM website (<http://www.havelockbelmontmethuen.on.ca/>).

Review the ZBL (zoning by-laws) for your municipality which may define local laws around waterfront properties (setbacks, boathouses, lot sizes and density of lot coverage, for example).

Give FOCA your feedback and input on solutions for sustainable land use planning.

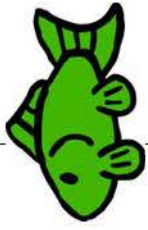

Canoeing/Kayaking

- Know your limitations. Choose water that matches your skill level and never paddle near dams.
- Keep warm. Dress appropriately and consider investing in a neoprene suit, gloves and footwear.
- Always wear a properly fitted, approved Personal Flotation Device (PFD).

Stream Fishing

- Make sure your fishing locations have safe access points and a manageable current.
- Don't wade too deep, and wear a belt over waders to prevent water from seeping over the top.
- Bring along a wading staff for stability and probing bottom.

Hiking

- Be prepared! Have a map of your route and leave a copy with someone at home, and always let them know when to expect you back.
- Keep to marked trails and obey all posted signs; they're there for your safety.
- Avoid hiking too close to moving water during the spring. Water levels can rise to dangerous levels if a dam is released or the weather turns.

Boating/Personal Watercraft (PWC)

- Everyone on board should wear an approved PFD.
- Be weather wise. Head for shore the minute the weather turns for the worse.
- Never overload your boat or enter water that your boat can't handle.

Fishing

- Never fish below a dam. Water levels can change faster than you can react.
- Always anchor in a safe flow. Heavy currents can work against taut anchor lines and pull you under.

Swimming

- Always swim with someone else or make sure someone is watching from shore.
- Avoid swimming near dams or in areas of heavy current.

Camping

- Arrive at your campsite during the day so you can check for water or other hazards before you set up camp.
- Set up camp at least 200 feet from any shoreline.
- When drawing water for camp, choose a safe location with stable footing.

Tips for Kids

- Kids must wear a life jacket when in a canoe or kayak, but consider always putting a PFD on younger kids when you're around water.
- Help keep your kids safe around water and enrol them in a water-safety course or swimming lessons before the summer begins.

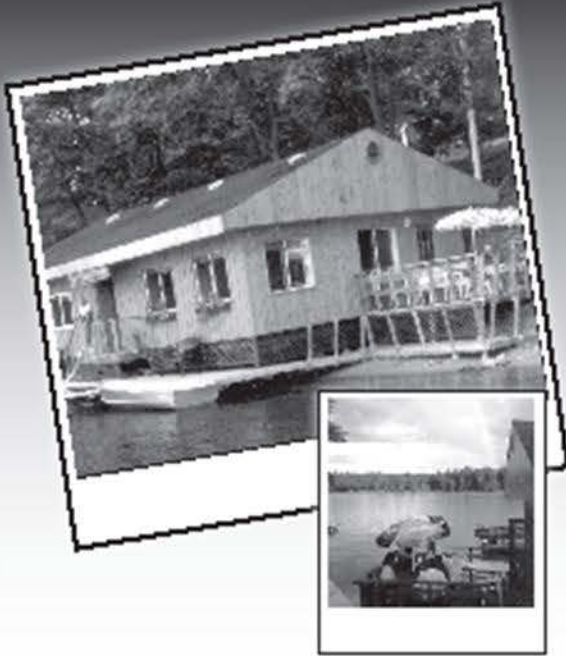

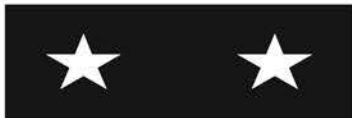

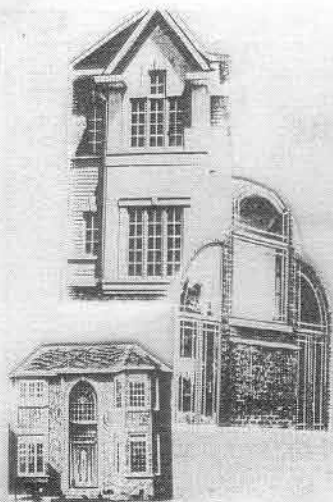

Fire Pump Instructions

In each of the pump houses located strategically around the lake there should be a pump, intake hose with a foot-valve, fire hose, small can of gasoline, a plastic container for priming, hand bell and a copy of these instructions. At each of the marinas, 2 additional 50 ft. lengths of hose are kept for use when needed.

1. En route to the fire, call for help by ringing the bell. Take along these instructions.
2. See that there is oil in the crankcase and gasoline in the tank of the pump engine (either clear or mixed gas as for outboards)
3. Set intake pipe in water with foot valve as nearly vertical as possible. Fill the pipe with water (foot valve prevents water from running out) and attach to pump, avoid damaging the foot valve screen.
4. Prime the pump by tilting it and pouring water into the output opening, fill to overflowing and then attach fire hose.

CAUTION: Do not run without water in pump or oil (SAE 30) in crankcase.

Starting: ~ Old Pumps ~

- A. Pull Choke Control
- B. Push Stop Switch away from the spark plug
- C. Use Pull Cord
- D. When Motor starts Push in Choke Control



To Stop: Push Stop Switch against the end of the spark plug.

Starting: ~ New Pumps ~

- A. Turn Ignition Switch to ON
- B. Move Gas Lever to ON
- C. Move Choke Lever to ON
- D. Use pull cord
- E. Turn choke off when motor starts
- F. Move throttle to FAST

To Stop: Turn ignition switch to OFF

AFTER USING: 1. Clean and dry suction pipe and hose before replacing in the pump house.

2. Report the use of the pump to any member of the Executive.

Note that the Lake Kasshabog Residents' Association is not responsible for ensuring pumps have gas and are operational. If you use a pump please leave it in good working order.

NOTE: An Open Air Burning By-Law is in place in the Township which is applicable January to December of each year.

- All open air burning must be done in compliance with the Forest Fire Prevention Act.
- All open air burning done during daytime hours, being 2 hours after sunrise and up to 2 hours before sunset will require a permit, to be issued by the Fire Chief or his designate.

Any person setting, maintaining or allowing to burn, a fire and all property owners upon which a fire is set, maintained or allowed to burn in open air:

- shall, be responsible for any damage to property occasioned by said fire
- shall, if the fire is not permitted pursuant to the by-law or does not otherwise comply with the regulations set out herein, be liable for the payment of a fee comprised of the cost of any fire fighting equipment and personnel.
